All tickets for International matches ordered and supplied are subject to RFU terms and conditions. No member may sell or dispose of tickets to anyone, if not required for the members' personal use. Tickets may not be used as raffle/draw/competition prizes. If you are allocated tickets the club is entitled to know details of who accompanies you to the game and you must download the Twickenham app in order to receive tickets. The club keeps a record of all tickets and recipients. Details may be requested by the RFU for up to 12 months after a match. Checks are carried out at all international matches. If any tickets allocated to Rosslyn Park Football Club are discovered on the black market or used by unauthorised persons the RFU may sanction the member and/or the club, which may lose part or the whole of its allocation for future matches.

Please note that we have been advised by the RFU Ticket Office that photographs of tickets must not be placed on social media sites. This has recently resulted in tickets being copied and advertised illegally by third parties, resulting in possible sanctions on the clubs involved.
